Copyright protects an "original work" "fixed in a tangible medium of expression"

Defamation, privacy and the right of publicity:

The warranty clause: Or, I'm promising what?

- Sole author of the work, sole and exclusive owner of the rights

- The work is:
 - Original
 - Does not infringe
 - The work is innocent
 - The Work has not heretofore been published

- The Publisher may rely upon the representations in dealings with any third party
